

**THIRD AMENDMENT TO AND RENEWAL OF AGREEMENT BETWEEN THE OHIO
ATTORNEY GENERAL AND JONAS C & R SOFTWARE**

WHEREAS, the Ohio Attorney General (“Attorney General”) and Fair Isaac Corporation (“FICO”) entered into an Agreement Between the Attorney General and FICO effective on May 5, 2020 expiring on June 30, 2021 (AGO Agreement #9643); a First Amendment to the Agreement effective July 1, 2021 and expiring on June 30, 2022; and a Second Amendment to the Agreement effective July 1, 2022 and expiring on June 30, 2023; and

WHEREAS, FICO sold or otherwise transferred assets to Jonas Collections and Recovery Inc. (“Jonas C&R Software”) including FICO’s Debt Manager business;

WHEREAS, Jonas C&R Software agreed to assume certain FICO obligations concerning Debt Manager including those obligations specified in the Agreement;

WHEREAS, the Attorney General and Jonas C&R Software desire to renew the Agreement for an additional one-year term from July 1, 2023 through June 30, 2024; and

NOW THEREFORE, the Attorney General and Jonas C&R agree to enter into this Third Amendment to and Renewal of the Agreement as follows:


1. Pursuant to Section 9.1 of the Agreement, the parties agree to renew the Agreement. The time of performance for the renewed Agreement shall begin on July 1, 2023 and expire no later than June 30, 2024 (“Third Renewal Period”).
2. Amend Exhibit B to the Agreement to include the attached “Exhibit B FY24” setting forth the agreed-upon services and pricing for the Third Renewal Period. The Attorney General shall pay Jonas C & R no more than \$465,216.53 for the Third Renewal Period.
3. All other terms and conditions of the Agreement remain the same.
4. This Third Amendment to and Renewal of the Agreement is effective as of the latest date of signature below, and the Renewal is effective as of July 1, 2023.
