Federal Fund Match Requirement

The NOAA federal grants are matched with funds from State Funds 5140 and 6970 and Subrecipient match amounts. The CZM awards are matched at 50% (the items on this list do not require additional match) and the NERR awards are matched at 30%.

The USEPA grants do not require any state matching funds.

Funding for State Fund 5140 is collected as royalties from companies mining salt under Lake Erie and from the mining of sand and gravel from the bed of Lake Erie, in accordance with O.R.C. 1505.07 and 1506.41.

Funding for State Fund 6970 is received through the administration of Submerged Lands Leases in accordance with O.R.C. 1506.02 and 1506.11.
