The Department of Rehabilitation and Correction respectfully requests Controlling Board approval for a waiver of competitive selection in the not-to-exceed amount of \$7,330,000.00 from GRF, ALI 505321 (Institution Medical Services), in FY22 and FY23, to obtain emergency medical treatment and medical services for incarcerated people at various institutions.

The Department is responsible for providing medical care as needed to incarcerated people in our custody. In addition to providing medical services to inmates inside correctional facilities, emergency medical situations require the treatment of inmates by public or private hospitals and physicians. Correctional facilities are located throughout the state, and the providers of emergency medical services are limited to those in the closest proximity to the facility.

This operating request will enable the Department to obtain emergency medical treatment and medical services as needed from

various hospitals, medical centers and medical providers throughout the state. The proposed amount for each vendor is based on prior spending and anticipated need.
