Offeror Cost Proposal

The Offeror's Cost Proposal must include an estimated total annual cost. Rates must be shown in the form of whole dollars. The quoted rates must encompass all administrative and overhead costs. Once the selected Offeror's Cost Proposal is accepted, the rates identified therein will be considered firm and all-inclusive.

Offeror Administrative Costs

Offerors are to include all administrative expenses and other costs into their stated rates. Offeror's administrative expenses include, but are not limited to, all costs related to the administrative activities of the project including personnel salaries, fringe benefits, vacation, holiday pay, sick leave, other paid leave, pension plan, group insurance, worker's compensation insurance, payroll taxes, repair and maintenance, employee-related expenses, supplies, communications, leases, depreciation, sales taxes, facilities, travel, etc.

Offeror Indirect Costs

ODM has deemed it unnecessary for the project to incur indirect costs. All costs should be factored into the stated rates.

Cost Proposal Consideration and Offeror Selection

Only those Offerors that meet the minimum scoring threshold in the Technical Proposal Score Sheet will advance to the second phase of the selection process—consideration of Offeror cost proposals.

The actual value of the contract will be determined by ODM based on the selected Offeror's proposed and accepted prices and the best estimation possible by ODM for the level or volume of each of those services likely to be utilized, and the amount of funds available. Work may only be started upon issuance of a purchase order.
