

Agreement for Purchase of Goods and/or Services Amendment

The original agreement #CTR021032 was fully executed on **04/25/2024**, between the Ohio Department of Developmental Disabilities, on behalf of the **Northwest Ohio Developmental Center**, hereinafter referred to as “Agency”, and **PAYKO Contracting LLC.**, hereinafter referred to as “supplier”.

The following information replaces the existing language in the original agreement.

AGREEMENT MODIFICATIONS:

SECTION B. EFFECTIVE DATES

This agreement is effective on **April 16, 2024**, and shall expire on **June 30, 2025**, unless terminated prior thereto pursuant to Section G. Services shall not begin until Agency receives OBM approved Purchase Order.

SECTION C. COMPENSATION

1. The Agency agrees to pay the Supplier at the rates set forth in the **supplier’s quote** dated **April 12, 2024**, on a reimbursement basis upon the Agency’s receipt and approval of proper invoices for the residential building flooring services purchased hereunder.

The Agency also agrees to pay Supplier at the rates set forth in the **Supplier’s quote** received on **August 16, 2024**, on a reimbursement basis upon the Agency’s receipt and approval of proper invoices for the bedroom flooring services purchased hereunder.

The total maximum compensation to be paid to the Supplier under this agreement shall not exceed **three hundred fifty one thousand seven hundred eighty six dollars and cents (\$351,786.00)**.

SECTION D. GOODS AND/OR SERVICES *(remove section if not applicable to amendment)*

1. Supplier shall undertake and complete the work and activities as set forth in the Supplier’s dated **April 12, 2024**.

Under this amendment, supplier shall also undertake and complete the work, and activities set forth in the Supplier’s **quote** received on **August 16, 2024**.

Supplier shall consult with personnel of the Northwest Ohio Developmental Center if additional goods and/or services are identified as necessary for the performance of this agreement and must be agreed upon in writing by both parties before additional work is performed.

All other terms and conditions of the original agreement remain in force as originally agreed upon.
