FIRST AMENDMENT TO AGREEMENT FOR SERVICES

This First Amendment to Agreement for Services (this "Amendment") is made and entered into, effective as of the latest date of signature below (the "Effective Date"), by and between the State of Ohio, Department of Development ("Sponsor"); and Cincinnati Association for the Blind and Visually Impaired ("Contractor").

RECITALS

WHEREAS, Sponsor and Contractor entered into that certain Agreement for Services, dated effective as May 11, 2021 (the "Original Agreement"); and

WHEREAS, pursuant to Section 26(g) of the Agreement, the parties wish to amend the Original Agreement in order to increase the amount of compensation to Contractor for services performed for Fiscal Year 2023 by Thirty-Five Thousand and NO/100 Dollars (\$35,000.00).

NOW, THEREFORE, in consideration of mutual benefits and promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties, intending to be bound, hereby agree as follows:

1. The third sentence of Section 4 in the Original Agreement is deleted in its entirety and replaced with the following:

The total compensation to be paid to Contractor under this Agreement shall not exceed Four Hundred One Thousand and NO/100 Dollars (\$401,000.00), which consists of up to One Hundred Eighty-Three Thousand and NO/100 Dollars (\$183,000.00) for fulfillment services rendered and administrative expenses for the period beginning July 1, 2021 through June 30, 2022 ("FY 2022 Funds") and up to Two Hundred Eighteen Thousand and NO/100 Dollars (\$218,000.00) for fulfillment services rendered and administrative expenses for the period beginning July 1, 2022 through June 30, 2023 ("FY 2023 Funds").

2. This Amendment will become a part of the Original Agreement on the Effective Date. All other terms and conditions in the Original Agreement remain in full force and effect and are binding on the parties. This Amendment and the Original Agreement remain in full force and effect and are binding on the parties. This Amendment and the Original Agreement set forth the entire understanding between the parties as to the subject matters herein, and in the event there are any inconsistencies between the two documents, the terms of this Amendment control.
