### Overview of Institutions/Agencies Purchasing Process

A. Describe the agency's efforts to meet the 15% MBE requirement for goods and services: Central State University utilizes the competitive selection process for procurement of goods, services and construction. State-Term and IUC agreements are utilized for goods and services to leverage procurement where feasible. For goods and services not procured via State-Term and IUC agreements, the competitive selection process is executed via Request for Quotation (RFQ), Request for Proposal (RFP), Request for Qualifications (RFQ), and formal sealed bid. Selection and award is based upon lowest, responsive, awardable submittal. Central State University has procurement diversity goals of 15% MBE and 5% EDGE for goods and services.

B. Describe the agency's Efforts to meet EDGE participation goals for construction projects: Central State University includes EDGE/MBE objectives in capital projects to include EDGE and MBE participation. The EDGE objective is 5% of construction. The MBE goal is 15% of construction. Contractors are required to submit their EDGE/MBE plans and progress is monitored and measured throughout the duration of the project. All bids are distributed statewide to MBE development councils and organizations and statewide for the widest communication of the opportunity.
