Construction and Architect/Engineering procurement is managed by the Office of Facilities Operations and Development in accordance with ORC 153 and OFCC guidelines. The procurement of goods and services is coordinated by Facilities Operations and Development in partnership with the University Purchasing Department.

### Describe Institution's Efforts to Meet EDGE/MBE participation goals for Capital Projects

The University has made an effort to commit to 5% EDGE participation on every construction and architecture & engineering contract. To encourage EDGE participation the University commitment is emphasized in every architecture & engineering interview and every construction pre-bid meeting. Each vendor the University is considering doing business with is asked to identify to the University if they are an EDGE certified vendor, or will be able to obtain a minimum 5% EDGE participation with consultants, subcontractors or material suppliers. When a vendor states that they will be unable to meet or exceed 5% EDGE participation Facilities Operations & Development will work with them to identify opportunities.

University Purchasing Department staff attends minority business trade events and has hosted events for minority vendors to learn about the University. In addition, the University has produced materials to help vendors understand the requirements and process of becoming a certified MBE or EDGE vendor. University Purchasing runs reports and reviews goods and services spend on a quarterly basis and all University departments have the ability to run these same reports on their own.
