This AMENDMENT NO. 9 TO AGREEMENT OF SUBLEASE ("Amendment"), dated as of March 20,303 between the DEPARTMENT OF YOUTH SERVICES (the "Department") and the BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF BUTLER, OHIO (the "Board");

WITNESSETH:

WHEREAS, the Department and the Board previously entered into an Agreement of Sublease (as the same has been amended previously, the "Original Sublease") with respect to the Butler County Juvenile Detention & Rehabilitation Center (the "Project"); and

WHEREAS, the parties hereto desire to amend the description of the Project set forth in Exhibit A to the Original Sublease in order to more accurately describe the Project;

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein set forth, the parties hereto agree as follows:

Section 1. <u>Amendment and Restatement of Exhibit A</u>. Exhibit A to the Original Sublease is hereby amended and restated in its entirety in the form of 9th Amended and Restated Exhibit A attached hereto and made a part hereof.

Section 2. <u>Original Sublease Unaltered</u>. Except as expressly modified hereby, the Original Sublease remains unaltered and in full force and effect. This Amendment shall be considered an

integral part of the Original Sublease and all references to the Sublease in the Original Sublease or any document referring thereto shall, on and after the date of this Amendment, be deemed to be references to the Original Sublease, as amended, including as amended by this Amendment.
