

**FOURTH AMENDMENT TO AGREEMENT BETWEEN THE OHIO ATTORNEY
GENERAL AND APPRISS INSIGHTS, LLC.**

WHEREAS, the Ohio Attorney General (“Attorney General”) and Appriss Insights, LLC. (“Consultant”) entered into an Agreement between the Ohio Attorney General and Appriss Insights, LLC. effective on June 18, 2019 and expiring on June 30, 2021 (the “Agreement”), a First Amendment to the Agreement effective on June 15, 2021 and expiring on June 30, 2023; a Second Amendment to the Agreement was effective on June 16, 2021; a Third Amendment effective on July 1, 2023 and expiring on June 30, 2025; and

WHEREAS, the Attorney General and Consultant now desire to amend the Agreement to change and add new provisions under the Agreement;

NOW THEREFORE, the Attorney General and Consultant agree to enter into this Fourth Amendment to the Agreement (“Fourth Amendment”) as follows:

1. Delete Section IV(A) and replace it with the following: “The Attorney General shall pay Consultant no more than \$683,708.72 for the Work in Fiscal Year 2024, and no more than \$733,849.80 for the Work in Fiscal Year 2025.”
2. Edit Exhibit 1 to add the attached “Exhibit 1 Addition” to the Scope of Work.
3. All other terms and conditions of the Agreement remain the same.
4. This Fourth Amendment is effective as of date of signature below.
