BE IT KNOWN, that the parties have agreed to the following amendment(s) of the Agreement entered into between Opportunities for Ohioans with Disabilities Agency (OOD) and Premier Construction and Design (Contractor), for the period of September 19, 2022 through June 30, 2023. The amendment(s) to the agreement are limited to the specific items, articles, sections, subsections and/or exhibits/attachments as outlined below. All other items, articles, sections, subsections, exhibits/attachments, terms and conditions and any previous amendment(s) of the same aforementioned agreement, not otherwise affected by the amendment(s) here, shall remain in full force and effect as written. The amendment(s) hereto shall supersede any prior amendment(s) of the same terms.

THEREFORE, page 1 of the Contract and Agreement, 3rd paragraph of the aforementioned agreement, is amended to read as follows:

This Agreement shall be in effect, unless terminated per the appropriate section of the terms and conditions, from September 19, 2022 through December 31, 2023. In no event shall this Agreement be construed to financially obligate OOD beyond the current biennium. If OOD chooses to renew this Agreement on the same terms and conditions beyond any current biennium, OOD shall provide written notice of such renewal to Contractor prior to expiration. If this Agreement is not renewed, OOD shall pay all proper invoices received prior to termination or any proper invoice received by OOD after termination for services rendered proper to termination. This Agreement is not binding upon the parties unless fully executed.

All other terms and provisions of said Agreement shall remain in full force and effect as written.
